#### 4. FIRST AID MEASURES

#### 5. FIRE-FIGHTING MEASURES

##### Suitable Extinguishing Media

Water fog. Dry chemical. Carbon dioxide (CO<sub>2</sub>). Cool containers/tanks with water spray.

**Unsuitable Extinguishing Media** Keep away from sources of ignition - No smoking. Cool containers / tanks with water spray.
